MINISTRY OF EDUCATION AND PROFESSIONAL TRAINING SCHOLARSHIP

- General scholarships offered by the Ministry of Education and Professional Training

- **Important**

Read the rules of the announcement carefully and take them into account in order to matriculate correctly.

The scholarship application must be registered in the computer application of the Ministry of Education and Professional Training, once the call for applications has been published in the BOE (Official State Gazette).

- **Effects on matriculation of rejection or withdrawal of the scholarship**

Those students who are going to apply for a grant and meet the academic requirements to be beneficiaries can select the option "Becario MEC" in the matriculation application and formalise their matriculation without the prior payment of the public fees for academic services for the credits for which they are matriculating for the first time.

Students using this option whose scholarship application is rejected or whose scholarship is withdrawn:

- a) They are obliged to pay the full amount of the matriculation fees. The university will recalculate the amount to be paid in a single payment or in instalments in the number of receipts remaining until June.
- b) The rejection or revocation of the grant is not considered grounds for requesting the cancellation of the matriculation. Students who, on formalising their matriculation, take advantage of the price exemption for having applied for an MEC grant, and subsequently do not obtain it, are obliged to pay the price corresponding to the matriculation they made. Failure to pay generates a debt in favour of the university, the payment of which will be required as a prior condition for subsequent matriculation in the same or other courses at the UAH, as well as for access to academic services. Students will not be able to apply for the issue of degrees and certificates while you have outstanding payments to be made.

✓ **Documents to be uploaded.** You do not have to present proof of having applied for the MEC scholarship, nor the scholarship holder's credential or the resolution denying you the scholarship, unless we expressly ask you to do so.

- **Postgraduate studies for which reduction or exemption may be requested:**

- ✓ Official Master's Degrees.

UAH GRANTS FOR UNIVERSITY MASTER'S DEGREES: OWN CALLS OR THROUGH AGREEMENTS WITH OTHER INSTITUTIONS

- **Reductions and exemptions :**
 - ✓ They shall comply with the provisions of the calls for applications or the respective MEC Agreements, where applicable.
 - ✓ The appropriate reduction or exemption will be applied at Postgraduate and Non-Regulated Studies Students Office when the registration period finishes.

EXEMPTIONS AND REDUCTIONS

- **Large family**

Special category large family. Exemptions:	General category large family. Reductions:

- **Requisites to qualify for assistance:**

Large Family Card, which must be current at some time between the date of matriculation and the date of payment of the first electronically generated matriculation receipt, both included, or between the issue and payment dates of the receipt or between the date of issue and the due date of the receipt for payment of other services of an academic nature.
- **Documents to be presented, period and way of presentation:**
 - ✓ Copy of the **Large Family Card** showing, in addition to the commencement and renewal dates, the names of all beneficiaries, issued by the competent body of the Spanish administration or a copy of proof of having submitted to the competent administration the application for obtaining or renewing the official certificate accrediting large family status. In order to benefit from this, the application must be in force on one of the days between the date of matriculation and the due date, both included, of the first matriculation receipt generated, or between the date of issue and the due date of the receipt for the payment of other academic services.

Within 10 days of notification of the decision to grant or renew your status as a large family, you must submit a copy of the certificate so that your file is complete.

- ✓ Before the matriculation payment period commences or before applying other services of an academic nature, unless already presented when registering or in previous academic years and still valid; failure to present means there will no reduction or exemption from payment of the fee for matriculation, or other services of an academic nature and will be regarded as renunciation of same.
 - ✓ Online application using the [Form for online documents submission](#)
 - **Postgraduate programmes for which reductions and exemptions may be applied for:**
 - ✓ University Master's degrees, Open Postgraduate Programme or Short Courses.
- **Victims of terrorism**

And their spouses and children in accordance with the stipulations of *article 7 of Law 32/1999 of 8 October (Official State Bulletin of 9 October)*

- **Exemption:**
 - ✓ Prices for academic services.
 - ✓ The price of the diploma and other Secretariat prices included in Annex V of DECREE 43/2022, of 29 June, of the Governing Council of the Community of Madrid (B.O.C.M. number 155 of 1 July 2022).
 - **Requisites to qualify for assistance**
The administrative ruling must be current at some time between the date of matriculation and the date of payment of the first electronically generated matriculation receipt, both included.
 - **Documentation to be presented period and way of presentation:**
 - ✓ Copy of the administrative ruling recognising victim of terrorism status, issued by the competent body of the Spanish Administration.
 - ✓ Before the matriculation payment period commences, unless already presented when registering or in previous academic years and still valid; failure to present means there will no reduction or exemption from payment of the fee for matriculation and will be regarded as renunciation of same.
 - ✓ Online application using the [Form for online documents submission](#)
 - **Postgraduate courses eligible for the reduction:**
 - ✓ University Master's degrees, Open Postgraduate Programme or Short Courses-
- **Orphans of government officials, civilian or military, killed on active service**

For students without independent means aged under 25 years old.

- **Exemption:**
 - ✓ 100% of the price for administrative services on matriculation for the first time.

- ✓ Does not include the fee for administrative services staff and school insurance, where appropriate.
 - **Documentation to be presented period and way of presentation:**
 - ✓ Copy of the family record book and the certificate from the organisation to which the deceased dying on active service belonged, certifying those circumstances.
 - ✓ Before the matriculation payment period commences, unless already presented when registering or in previous academic years and still valid; failure to present means there will no reduction or exemption from payment of the fee for matriculation, and will be regarded as renunciation of same.
 - ✓ Online application using the [Form for online documents submission](#)
 - **Postgraduate courses eligible for the reduction:**
 - ✓ University Master's degrees, Open Postgraduate Programme or Short Courses-
- **Disabled students**

Students with a level of disability of 33% or more are deemed eligible.

Social Security pensioners who have been granted a permanent disability pension in the degree of total, absolute or severe disability, will be considered disabled persons with a degree equivalent to 33%. Likewise, passive class pensioners who have a retirement pension or a pension for permanent incapacity for service. In these cases it will be accredited by means of the disability report and the INSS pension certificate.

- **Exemption:**
 - ✓ 100% of the amount for academic services.
 - ✓ The price of the diploma and other Secretariat prices included in Annex V of DECREE 43/2022, of 29 June, of the Governing Council of the Community of Madrid (B.O.C.M. number 155 of 1 July 2022).
- **Requisites to qualify for assistance**
The administrative ruling must be current at some time between the date of matriculation and the date of payment of the first electronically generated matriculation receipt, both included.
- **Documentation to be presented, period and way of presentation:**
 - ✓ Copy of the administrative ruling recognising disabled status, issued by the competent body of the Spanish Administration.
 - ✓ Before the matriculation payment period commences, unless already presented when registering or in previous academic years and still valid; failure to present means there will no reduction or exemption from payment of the fee for matriculation, and will be regarded as renunciation of same.
 - ✓ Online application using the [Form for online documents submission](#)
- **Postgraduate courses eligible for the reduction:**
 - ✓ University Master's degrees, Open Postgraduate Programme or Short Courses-

- **Victims of gender violence**

- **Exemption:**

- ✓ 100% of fees for credits on first matriculation.
- ✓ The price of the diploma and other Secretariat prices included in Annex V of DECREE 43/2022, of 29 June, of the Governing Council of the Community of Madrid (B.O.C.M. number 155 of 1 July 2022).

- **Requirements to qualify:**

- ✓ The documentation accrediting situations of gender violence must be in force on one of the days between the date of matriculation and the expiry date, both included, of the first matriculation receipt generated.
- ✓ The children of victims of gender violence may also benefit from the exemption from payment of public prices by providing documentation of their mother's status as a victim of gender-based violence and also accrediting their own economic dependency.

- **Documentation to be submitted, deadline and form of submission:**

- ✓ A conviction for a crime of gender-based violence, or a protection order or any other court decision granting a precautionary measure in favour of the victim, or a report from the Public Prosecutor's Office indicating that there are indications that the plaintiff is a victim of gender-based violence.
- ✓ Situations of gender violence may also be accredited by means of a report from the social services, specialised services, or shelter services for victims of gender violence of the competent Public Body; or by any other means, whenever this is provided for in the sectoral regulations governing access to each of the rights and resources.
- ✓ Before the matriculation period begins, unless it has already been presented when pre-registering; if it is not presented, the matriculation fee exemption will not be activated, and it will be understood that it has been declined.
- ✓ Online: using the [form for online document submission](#).

- **Postgraduate studies for which exemptions may be requested:**

- ✓ University Master's Degrees, Open Postgraduate Programmes and Postgraduate Short Courses.

- **Participants in international peace and security operations**

Those who suffer disabling injuries falling within the scope of Royal Decree-Law 8/2004, of 5 November, on compensation for persons participating in international peace and security operations, as well as the children and spouses of the deceased.

- **Exemption:**
 - ✓ From the payment of fees and public prices.
 - ✓ The price of the diploma and other Secretariat prices included in Annex V of DECREE 43/2022, of 29 June, of the Governing Council of the Community of Madrid (B.O.C.M. number 155 of 1 July 2022).
 - **Requirements to be eligible:**

The administrative resolution must be in force on one of the days between the date of enrolment and the expiry date, both included, of the first enrolment receipt generated.
 - **Documentation to be presented, deadline and form of presentation:**
 - ✓ Copy of the administrative resolution issued by the corresponding body of the Spanish Administration by which the status has been recognised.
 - ✓ Before the start of the enrolment period, unless it has already been presented during pre-enrolment or in previous courses; if it is not presented, the exemption from the enrolment fee will not be activated and it will be understood that it has been waived.
 - ✓ Telematically: using the form for the telematic submission of documentation.
 - **Postgraduate studies for which the reduction can be requested:**
 - ✓ University Master's Degrees, Open Postgraduate Programme and Postgraduate Short Courses.
- **Beneficiaries of the minimum living income who are recognised as such.**

In accordance with the provisions of the seventh additional provision of Law 19/2021, of 20 December, which establishes the minimum living income.

- **Exemption:**
 - ✓ From the payment of fees and public prices.
 - ✓ The price of the diploma and other Secretariat prices included in Annex V of DECREE 43/2022, of 29 June, of the Governing Council of the Community of Madrid (B.O.C.M. number 155 of 1 July 2022).
- **Eligibility requirements:**

The administrative resolution must be in force on one of the days between the date of enrolment and the expiry date, both included, of the first enrolment receipt generated.
- **Documentation to be presented, deadline and form of presentation:**

- ✓ Copy of the administrative resolution issued by the corresponding body of the Spanish Administration recognising you as a beneficiary of the minimum living income.
- ✓ Before the start of the enrolment period, unless it has already been presented during pre-enrolment or in previous courses; if it is not presented, the exemption on the enrolment fee will not be activated, and it will be understood that it has been waived.
- ✓ Telematically: using the form for the telematic submission of documentation.
- **Postgraduate studies for which the reduction can be requested:**
 - ✓ University Master's Degrees, Open Postgraduate Programme and Postgraduate Short Courses.

DISCOUNTS

• Honours in Degree Course or Diploma course

The discount will only be applied once and will not be applied to transferred students.

- **Exemption:**
 - ✓ Students will receive a discount for the amount equivalent to 2 credits for every honours grade obtained in annual subjects in the last year of Degree courses, Diploma courses or the Degree Final Project at Spanish universities.
 - ✓ If the honours grade is obtained in four-monthly subjects, students will receive a discount for the amount equivalent to 1 credit.
 - ✓ The right to this exemption may not be applied in the event that the qualification of honours is the result of validation of subjects or recognition of credits.
 - ✓ These exemptions will be incompatible with obtaining grants and study aids that entail exemption from payment of the corresponding public fees.
- **Documentation to be presented:**
 - ✓ Copy of the personal academic certificate showing the honours in the subject/s concerned, unless the course was taken at the UAH.
 - ✓ Online application using the [Form for telematic shipment of documents](#)
- **Postgraduate courses eligible for the reduction:**
 - ✓ University Master's degrees.

• Honours in Postgraduate Courses

For honours obtained in subjects on a UAH University Master's degree.

- **Exemption:**
 - ✓ The amount equivalent to the credits obtained in Master's degree subjects.

- ✓ In no case will a number of honours registrations be applied that exceeds the number of subjects in which the student is enrolled, nor will the total amount of the deduction exceed the total amount of the registration fee.
- ✓ The right to this exemption may not be applied in the event that the qualification of honours is the result of validation of subjects or recognition of credits.
- ✓ These exemptions will be incompatible with obtaining grants and study aids that entail exemption from payment of the corresponding public fees.
- **Postgraduate courses eligible for the reduction:**
 - ✓ University Master's degrees, Open Postgraduate Programme or Short Courses.
